

ORDINANCE NO. 2026-01

**AN ORDINANCE ESTABLISHING SPEED LIMITS FOR MOTOR
VEHICLES ON ROADWAYS WITHIN SOMERSET TOWNSHIP,
SOMERSET COUNTY, PENNSYLVANIA**

WHEREAS, certain township roads, streets, and other thoroughfares, exist within Somerset Township where no speed limits have been established or a change in conditions has occurred to warrant a reevaluation of the speed limits previously adopted; and

WHEREAS, the Somerset Township Board of Supervisors, in order to advance the welfare and safety of the residents of the Township and such other persons who use said roads, streets, and other thoroughfares, deems it necessary to enact the speed limitations on certain roads, streets, and other thoroughfares in Somerset Township; and

WHEREAS, the Board of Supervisors, after completing engineering and traffic studies of the following roads, streets, and other thoroughfares, find the following speed limits to be warranted in accordance with the Vehicle Code of Pennsylvania.

NOW, THEREFORE, BE IT ENACTED AND ORDAINED, and it is enacted and ordained, by the Board of Supervisors of Somerset Township, as follows:

Section 1. The maximum speed limit for the following streets and roads is hereby established as follows:

<u>STREET OR ROAD</u>	<u>SPEED LIMIT (mph)</u>
1. Masonic Temple RD T-720	25

Section 2. This Ordinance shall be enforced in accordance with the provisions of the Vehicle Code of Pennsylvania as it pertains to fines and other penalties.

Section 3. Should any provision of this ordinance be found unconstitutional or otherwise illegal or in any other manner unenforceable, the remaining sections of the ordinance shall remain in full force and effect.

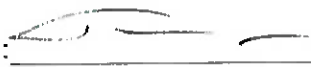
Section 4. This Ordinance shall become effective upon adoption and shall continue until amended or repealed by the Board of Supervisors of the Township of Somerset.
